CALL TO ORDER

APPROVAL OF MINUTES

A **MOTION** was made by Mr. Brue seconded by Ms. Rogers and approved to accept the September 22nd minutes.

FINANCIAL REPORT

A **MOTION** was made by Mr. Brue, seconded by Mr. Rabalais, and approved to accept the September 2025 financial reports.

NEW BUSINESS:

1. Director's Report

Mr. Gulledge will not give a formal "Director's Report" every month. Any questions by the board concerning his written report will be answered.

2. Discussion and Possible Consideration of Interfor Bond

Ben Brooks, Attorney at Smith, Gambell & Russell summarized, Interfor Bond Documents.

A **MOTION**, made by Mr. Rabalais, seconded by Mr. Brue and approved to adopt a resolution for Interfor. The Bond is limited in principal amount to a maximum of \$165,000,000. This bond is not backed by the IDA, county or school systems. Principal of the Bond shall be payable in ten (10) installments, due on December 1, 2026, and each December 1 thereafter, through December 1, 2035. The validation of the Bond is set for November 24th, 2025. This bond is replacing the 2019 bond, upon the issuance of the Bond, Interfor will be responsible to the IDA for their bond issuance fee of 1/8 of 1% in the amount of \$206,250, payable on January 15th, 2026.

3.. Brightmark's Second Extension on the Development Period

Brightmark exercised their second extension within the development period. Francisco Zubeldia | Senior Development Engineer, notified the IDA that they had wired \$62,500.00 to the escrow agent on October 2nd and according to the Purchase and Sales Agreement with the IDA and Brightmark, the notice and payment was made more than 15 days prior to the expiration of the initial development period. Brightmark can exercise its 3rd extension in six (6) months, beginning on the 15 days prior on March 26th, with the deadline on April 10th. The 3rd extension will be in the amount of \$62,500.00 as layout in the Purchase and Sale Agreement dated April 22, 2024. The P&S Agreement stipulates three more extensions of \$62,500.00 that are due at six (6) months increments and are non-refundable and will be added to and considered part of the earnest money to be applied to the purchase price at closing. NO Motion Needed

4. Discussion and Possible Consideration of JMF Towing & Recovery LLC Reconvey Title back to IDA

A **MOTION** was by Mr. Brue, seconded by Ms. Rogers and approved to reconvey title from JMF, LLC., for the 7.45 +- acres he purchased in the Thomaston-Upson Industrial Park. The amount to close on the property was \$166,305.20 minus the expenses incurred by TUCIDA in the amount of \$8,886.00. Original sales amount was \$175,000.00. No property tax is due. The closing date is set for Tuesday the 28th of October. Mr. Fortner has decided not to move forward with his project.
